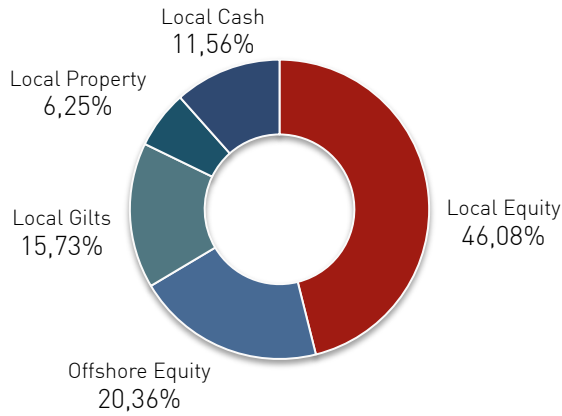

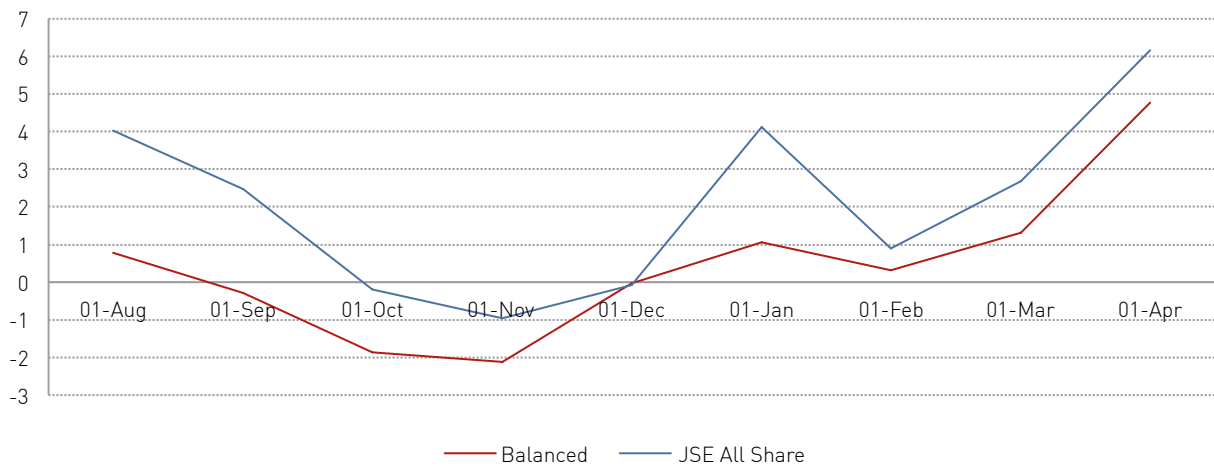

Sector Allocation

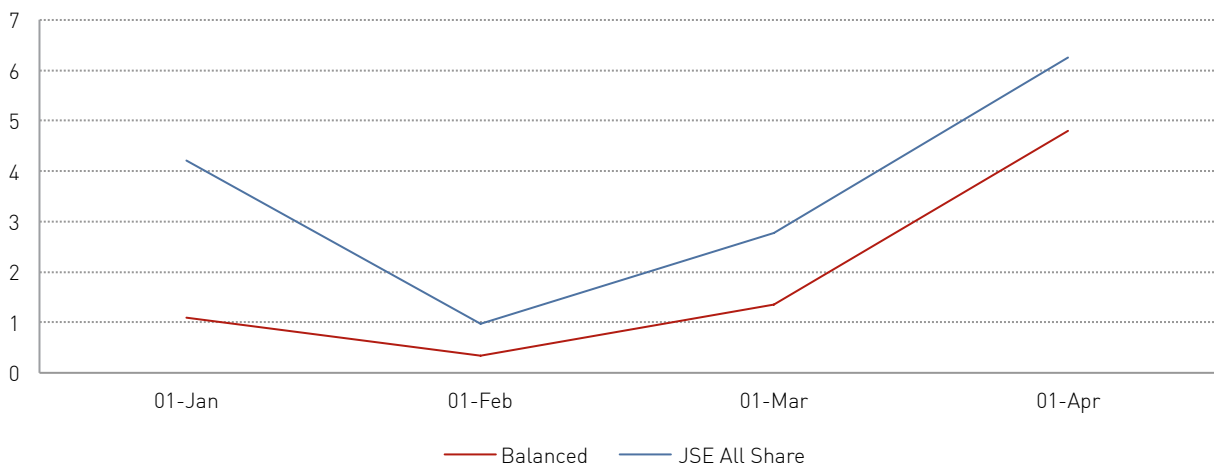


Performance Since Inception
